WATER RIGHT APPLICATION A033103 OF DEL PUERTO WATER DISTRICT TO APPROPRIATE WATER FROM DEL PUERTO CREEK TRIBUTARY TO SAN JOAQUIN RIVER IN STANISLAUS COUNTY

The State Water Resources Control Board, Division of Water Rights (Division) received the subject water right application of Del Puerto Water District and the San Joaquin River Exchange Contractors Water Authority (collectively, "Applicants") on January 23, 2020. The application requests 34,688 acre-feet of collection to storage in a proposed, 82,000 acre-foot reservoir located on Del Puerto Creek in western Stanislaus County. Water stored in the reservoir would be later withdrawn for irrigation use and released for instream uses (possibly fish and wildlife preservation and enhancement) downstream of the proposed dam. The primary purpose of the proposed reservoir would be to provide additional South-of-Delta storage to increase reliability of Central Valley Project water deliveries (via the Delta-Mendota Canal) to agricultural water users located within the Applicant's service districts.

Division staff has determined that the application includes an underpayment of \$485,470. Consequently, the application cannot be accepted for initial review. The application is hereby returned to the applicants. The submitted fee will also be refunded under separate cover.

Per California Code of Regulations, title 23, division 3, section 676, an application will not be accepted for initial review or filing unless it is accompanied by the filing fee required by chapter 5 (commencing with California Code of Regulations, title 23, section

1061). California Code of Regulations, title 23, section 1062, subdivision (a)(1)(A) requires water right applicants to pay a one-time application fee of \$1,000 plus \$15 per each acre-foot greater than 10 acre-feet based on the total annual amount of diversion sought by the application or \$553,919, whichever is less. The correct application filing fee for the proposed appropriation of 34,688 acre-feet is \$521,170. To help ensure that the application form is completed correctly, Division staff strongly encourage the Applicants to reference the guidance documents available on the Division's Water Rights Applications webpage, and schedule a pre-application consultation meeting or draft application review with Division staff prior to resubmitting the application form with the correct filing fee.
